<b>Family</b>	<b>€975</b>	<i>Family membership is made up of two full members and all children up to the age of 29</i>
<b>Ordinary</b>	<b>€645</b>	<i>Ordinary membership is open to any individual aged 30+</i>
<b>Ordinary Youth 19 – 29</b>	<b>€205</b>	<i>Youth membership is open to anyone aged 19 – 29 years. Proof of age may be required.</i>
<b>Ordinary Senior Over 65 (Pre 2013)</b>	<b>€205</b>	<i>Subscriptions for existing Senior Over 65 members as at the 31<sup>st</sup> December 2012</i>
<b>Ordinary Senior Over 65</b>	<b>€325</b>	<i>Senior Membership is open to anyone who is over 65 years of age and has been an ordinary member of the Royal Cork Yacht Club for 10 years.</i>
<b>Lady Associate (Existing)</b>	<b>€255</b>	<i>Lady Associate applies to Existing Lady Associate members only. Associate membership does not carry a vote.</i>
<b>Country</b>	<b>€280</b>	<i>Country is any individual whose principle residence is outside a 120km radius of Crosshaven, Co.Cork. Country Membership is not available to owners of boats kept in Cork Harbour.</i>
<b>Overseas</b>	<b>€280</b>	<i>Overseas membership is open to any individual whose principle residence is outside the Island of Ireland.</i>
<b>Cadets</b>	<b>€205</b>	<i>Cadet membership is open to candidates 18 years of age and under. <b>Please note:</b> Cadet members under 12 years of age will require an accompanying Adult member. If a parent/guardian of an under 12 cadet is not already a member of the Royal Cork Yacht Club, they may apply for an Associate Membership</i>
<b>Adult Associate</b>	<b>€155</b>	<i>A parent or guardian of an under 12 cadet may apply for Adult Associate Membership for a maximum of two years They may then apply for Ordinary/Family or Crew membership if they wish.</i>
<b>Corporate Associate</b>	<b>€2,500</b>	
<b>Crew Associate</b>	<b>€300</b>	<i>Crew Associate membership is open to new applicants, and may not be a boat owner. Boat owners may apply for Ordinary or Family membership. Associate membership does not carry a vote.</i>
<b>Overseas Life</b>	<b>€2750</b>
