PARKING OF VEHICLES, BOATS AND TRAILERS

Free parking of motorised vehicles is available to members while a member is on the club premises or out sailing for a maximum period of three weeks at a time.

The eastern car park, beside the Clubhouse, is intended for short term parking and should not be used for parking vehicles for extended periods.

Parking of boats and trailers is restricted to members except during open events when free parking may be provided at the Club's discretion.

Cars, boats, launching trollies and road trailers are parked entirely at the owner's risk. The Royal Cork Yacht Club shall not be responsible for any loss or damage however occasioned.

Payment is required for all boats, trailers and other vehicles which are parked in the car park and dinghy park. An application for a permit must be made on a Dinghy Park Booking Form accompanied by the appropriate payment.

A Dinghy Park Permit Tag or sticker acknowledging payment must be displayed on the boat and trailer at all times.

Boats and trailers are to be parked in an orderly manner.

It is recommended that trailers be secured and checked regularly by the owner.

All boats, trailers etc. must be kept in good condition so that they do not appear to be abandoned.

All boats and trailers are to be tagged with the owner's name and contact details. Boats trailers and trollies that are not tagged will be removed to a locked compound. It is the member's responsibility to put the sticker on the boat and the tag on the trailer.

Where payment for parking a boat or trailer has not been received by the Club, the Club will issue an invoice for the payment due and make reasonable efforts to contact the member if the boat is identifiable. If this action fails to resolve the matter, the boat and/or trailer will be removed from the Club site.

To release a boat or trailer from the compound area, the outstanding fees must be paid. Authority to release a boat or trailer is restricted to the General Manager, the Marina Manager or the Marina & Facility Supervisors who should be contacted in advance of requesting access.

Membership cards are for members use only. If a third party is required by a member to access the Club the member should ask the marina staff to arrange it or be present themselves. It is not permissible to give a member's card to a third party.

Activity at the gates and within the Dinghy Park is recorded on the card access management system and on CCTV.

DINGHY PARK OPERATION

Road access to and from the dinghy park and the slipway is via the east gate near the Dinghy Centre.

For safety reasons vehicles are not permitted in the dinghy park when there is sailing activity on the slip or near the Dinghy Centre.

After launching or recovery of vessels from the slipway, vehicles and other equipment must be removed immediately.

Single handed launching of RIBs or boats from trailers attached to vehicles is not permitted. A second person must be on hand to direct and assist the driver while launching or retrieving.

Club staff members are not responsible for any boat gear left unattended in the dinghy park.
